2.The petitioner has filed this writ petition seeking issuance of Writ of Mandamus directing the respondents to consider and approve petitioner's application bearing No.2022/09/08878 dated 26.09.2022.

3.The learned counsel appearing for the petitioner submitted that the petitioner made application dated 26.09.2022 to the respondents seeking building plan permission and the same has not yet been considered. Hence, this Court may, without going into the merits of the case, issue direction to the respondents to consider the petitioner's application dated 26.09.2022 and to pass appropriate orders, within a reasonable time frame.
