Prayer: Writ Petition filed under Article 226 of the Constitution of India praying for issuance of Writ of Mandamus, directing the 1st and 2nd respondents to dispose the 1st petitioner's father's Land Demarcation Application dated 27.03.2025 and petitioner's sub-division and patta name transfer applications dated 28.04.2025 and 24.06.2025 pertaining to the New (Sub Division) Survey No.130/2A, total measuring 1.18 Hecter (2.91 Acres) vide Joint Patta No.492 and comprising in New (Sub Division) Survey No.130/1, total measuring 0.32 Acre (79 Cents), vide Joint Patta No.288, situated at Sanniyasipettai Village, Paalur Post, Panruti Taluk, Cuddalore District within Registration District of Cuddalore District, Sub-Registration District of Panruti within a stipulated time.

2. Mr.S.Indhu Bala, learned Additional Government Pleader takes notice on behalf of the Respondents 1 & 2 and Mr.L.Baskaran, learned Government Advocate (Crl. Side) takes notice on behalf of the 3rd respondent.

3. By consent of the parties, the main writ petition is taken up for disposal at the admission stage itself.

4. The learned counsel for the Petitioners submitted that the Petitioners made a Land Demarcation Application dated 27.03.2025 and Sub-division and Patta Name Transfer Applications dated 28.04.2025 and 24.06.2025 with regard to the subject property through online before the 1st respondent. Despite the same, the Respondent has not taken any action on the applications made by the Petitioners and therefore the
