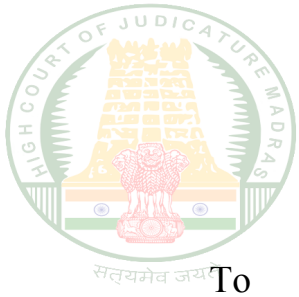
4. Recording the submission made by the learned Government Advocate, this Writ Petition stands closed. No costs.
