It is seen that the second respondent has relied upon the death report received from the concerned authority and incorporated the date. In any case, the representation given by the petitioner has been received and hence, there shall be a direction to the second respondent to convey the decision to the petitioner within a period of four (4) weeks from the date of receipt of a copy of this order.
