calling for the concerned records from the respondents, quash the order of the first respondent dated 02.11.2015 bearing Corporation Nilai Order (Permanent) Chairman cum Managing Director Nilai No.222, the order of the second respondent dated 21.03.2013 bearing Ku.A.No.001377/109/Ni/Pi.2(4)/2012-5 and the order of the third respondent dated 25.11.2011 bearing No. Ku.A.No.1293/Ni.Pi.1(2)/O.Na.22/2010-6 as illegal, arbitrary and contrary to law and consequently direct the respondents to restore the increment and pay arrears of pay and other benefits.

Prayer in W.P.No.22701 of 2017 : Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, after calling for the concerned records from the respondents, quash the order of the first respondent dated 20.02.2017 bearing No. Corporation Nilai Order (Permanent) Chairman cum Managing Director Nilai No.29, order of the second respondent dated 30.06.2016 bearing Ku.Order No.02667/118/Ni.Pi.2(4)/2016 dated 30.06.2016 and the order of the third respondent dated 28.01.2016 bearing No. Ku.O.No.691/Ni.Pi.1/U2/A No.7638/2013-5 as illegal, arbitrary and contrary to law and consequently direct the respondents to restore the increment of the petitioner and pay arrears.

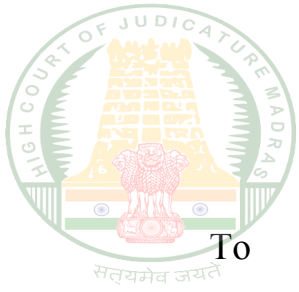
COMMON ORDER
