These Review Applications have been filed to review the order dated 08.09.2023 in W.P.Nos.6274 of 2014 passed by this Court.

2. The learned counsel for the petitioners would submit that the similarly placed persons approached this Court in W.P.No.37840 to 37847 of 2016, and this Court had taken a different stand. Therefore, the same order may be passed by reviewing the order passed by this Court.

3. On a perusal of the order dated 08.09.2023 passed by this Court in W.P.No.6274 of 2014 etc. batch and subsequent order dated 13.09.2023 passed by this Court in W.P.No.37840 to 37847 of 2016, it is revealed that the relief sought in those batches are not identical.
