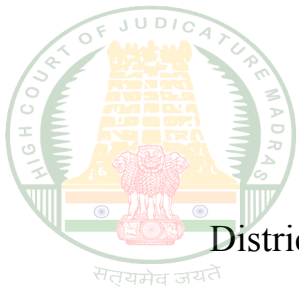

3. This writ petition is disposed of recording the above submission.

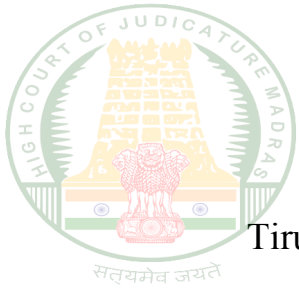
