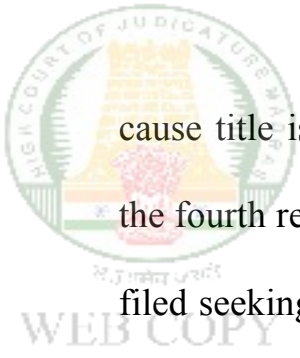

ORDER

(Order of the Court was made by the Hon'ble Dr.G.Jayachandran J.)
