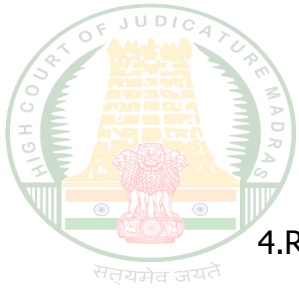

2. When the contempt petitions were taken up for hearing today, the compliance affidavit of the Chairman of TNPSC was produced and the relevant portions are extracted hereunder:

10. I submit that in compliance of the above said court order dated 05.09.2025 Oral Test was conducted for both the petitioners on 26.03.2025. Subsequently both the petitioners were selected and the Selection list has been forwarded to the appointing authority on 26.03.2025.

11. I submit that in such a scenario, in obedience to the directions of this Hon'ble High Court, TNPSC has completed the selection process in accordance with law and in tune with the directions of this Hon'ble Court.
