28.06.2022, especially in paragraph 9.

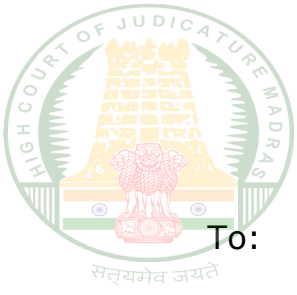
