### **ORDER**

3. When the matter was listed on 06.10.2025, there was no representation on behalf of the petitioner and the matter was directed to be listed on 27.10.2023 under the caption “for dismissal”. It appears that the cause does not survive any more for the petitioner and that being the reason, the petitioner is not intending to prosecute the case.
