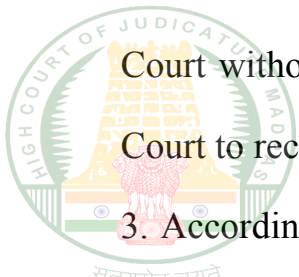

ORDER

This matter has been listed under the caption “For Being Mentioned”.

2. Today, the learned counsel for the petitioner would submit that due to typographical error, at paragraph No.3 of the order dated 25.08.2025, the date of the assessment order has been mentioned as “22.07.2025” instead of “21.02.2025”. Further, he would submit that at clause (ii) of paragraph No.9, it has been wrongly mentioned as “on such payment being made,”, however, in this order, the impugned order dated 22.07.2025 was set aside by this

Court without any condition for payment of additional deposit/cost. Hence, he

Court to rectify the said errors.

3. Accordingly, paragraph No.3 & clause (ii) of paragraph No.9 of the aforesaid order reads as follows:
