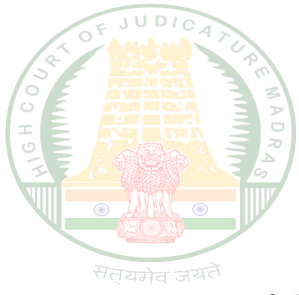
This petition is filed seeking a direction to the respondent to file a final report in Cr.No.179 of 2024 pending on his file.
