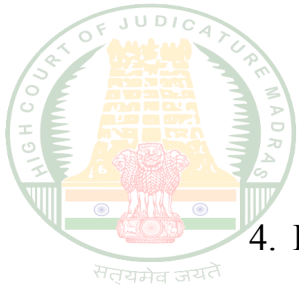
ORDER

In and *vide* the 'proceedings of R1 in Na.Ka.8251/2023/F1 dated 23.08.2023' (hereinafter 'impugned order' for the sake of convenience and clarity), R1 (Commissioner, Hosur Corporation) has directed removal of a compound wall on the ground that it is an encroachment *qua* 25 feet road in a layout.
