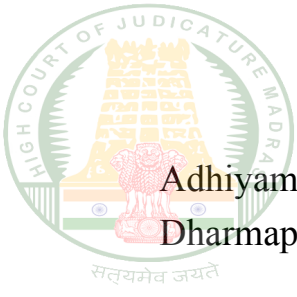

To set aside order passed by the Honble Court in WP No.27462/2009, dt. 01.08.2022.

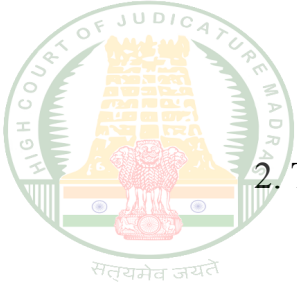
