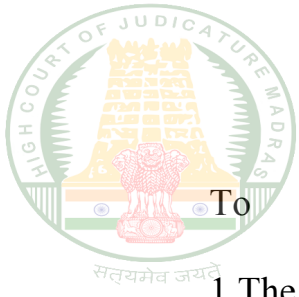
2. The learned Government Advocate (Crl. Side) appearing for the respondent police submits that the petitioners are scrupulously complying with the condition without any deviation.
