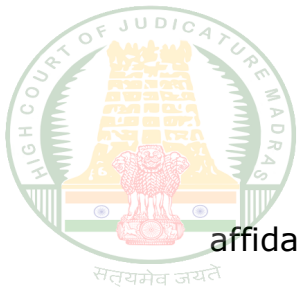
COMMON ORDER
