2.When the matter is taken up for consideration, the learned Standing Counsel would fairly submit that all the impugned orders have been passed without conducting any enquiry and would further submit that the respondents would like to withdraw the same, without prejudice to the disciplinary proceedings initiated against the petitioner vide charge memorandum dated 12.02.2025.
