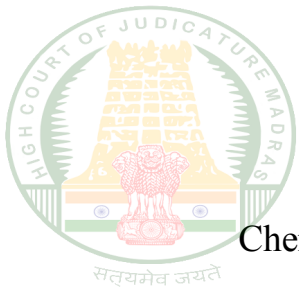

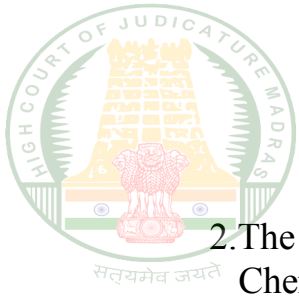
2. Even today, there is no representation by or on behalf of the petitioner. Hence, this miscellaneous petition is dismissed for non-prosecution. No costs.
