Prayer : Writ Petition is filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus, directing the second respondent to cancel the illegal patta obtained by the 4th, 5th & 6th respondents for the lands in Survey No.633/1B & 1A2 measuring to an extent of total 2601 sq.ft are situated at Othavadai Street, Block No.1, Madhavaram, Chennai – 600 051 on the light of enquiry conducted by the third respondent by proceeding bearing in Na.Ka.No.534/2018/A1 dated 23.02.2018 and pass appropriate orders thereon within a time frame that may be specified by this Court.
