ORDER

This Sua Motu case is dealt with in an extraordinary manner by this Dedicated Bench, pursuant to Sua Motu W.P.(Crl.)No.618 of 2025.

2. This is a complaint filed by the Drug Inspector against the accused, who is manufacturing and supplying the drugs of Not of Standard Quality (NSQ). It can be seen that the allegations are that the accused contravened Section 18(a)(i) of Drugs and Cosmetics Act, 1940. The complainant traced the supply chain from retailer to manufacturer as the six accused involved in manufacturing, stocking (or) selling the drugs, which are not of standard quality. The case is pending from the year 2014. Non-bailable warrant is pending against the accused A4 and A5.

3. Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to passage of time, a meaningful trial is unlikely, and no useful purpose would be served.
