2. The cases in Cr.No.527 of 2020 (case in C.C.No.68 of 2020) and Cr.No.528 of 2020 (counter case in C.C.No.456 of 2024 on the file of the Judicial Magistrate No.II, Salem) are registered for alleged offences under Sections 294(b), 323, 324 and 326 of the Indian Penal Code. The parties have moved on and have no objection to the case being disposed of on compromise. Due to the unique manner in which this designated bench conducts hybrid

hearings, the filing of written affidavits or terms of compromise is dispensed

with. Considering the factual matrix, the context in which the conflict arose, the background of the parties, and their present position, this is an appropriate case for the exercise of jurisdiction under Section 482 of the Code of Criminal Procedure as per *Gian Singh Vs. State of Punjab and Anr.*, [(2012) 10 SCC 303].

3. Accordingly, the cases in C.C.No.68 of 2022 and C.C.No.456 of 2024 on the file of the learned Judicial Magistrate II, Mettur Taluk, Salem, stands quashed. This Sua Motu Transfer Case is disposed of.
