3. Petition is dismissed. There shall be no order as to costs. Consequently, the interim application is also dismissed.

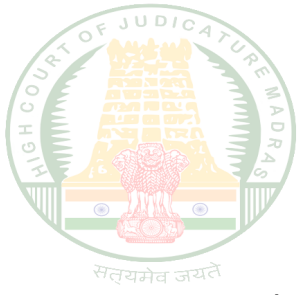
