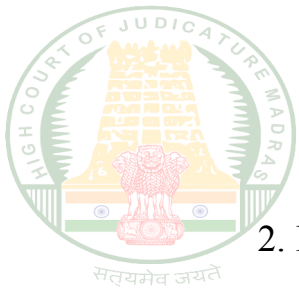

No costs. Consequently, connected Writ Miscellaneous Petitions are closed.

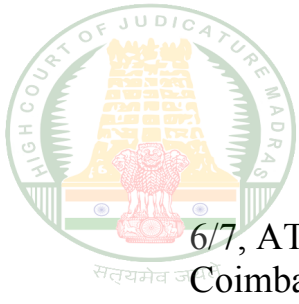
