ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

The allegation made in the writ petition is that respondent No.8 is developing a residential colony on an agricultural land which belongs to him.

2. As to how the petitioner would suffer any legal injury has not been disclosed in the petition. Irrespective of whether or not the activity of respondent No.8 is in accordance with law, petitioner lacks *locus standi*.

Petition is dismissed for want of *locus standi*. There shall be no order as to costs. Consequently, the interim applications stand closed.

It is made clear that this order shall not come in the way of official respondents in taking any action against 8th respondent.
