The occurrence is said to have taken place on 18.05.2016. The accused committed theft of defacto-complainant's gold chain. It is reported that the property involved in this case has been recovered and handed over to the defacto-complainant. The defacto-complainant does not want to pursue the case any further. There is no previous or subsequent case against the accused.

3.Considering the nature of the allegation, the antecedents of the accused and since the accused has been facing the case since 2017, any further continuation of the trial would impinge upon his right to a speedy trial of the accused and no useful purpose would be served.

4.Accordingly, the case in C.C.No.195 of 2017 of Judicial Magistrate Court, Dharapuram, Dharapuram Taluk, Tiruppur, stands quashed. This Suo Motu Transfer Case is disposed of.”
