3. The learned Special Government Pleader appearing on behalf of the respondents, has no objection for such an order being passed by this Court.

Considering the submissions made by the learned counsel appearing on either side, this Court without going into the merits of the case directs the 2nd respondent/Appellate Authority to pass orders on the Appeal filed by the petitioner dated **12.06.2025**, on merits and in accordance with law, after giving an opportunity of hearing to the petitioner and other parties concerned and inform the decision taken to the petitioner within a period of **twelve weeks** from the date of receipt of a copy of this order.

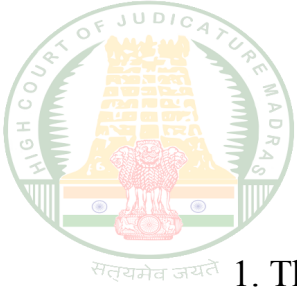
With the above directions, this Writ Petition is disposed of. No costs. Consequently, connected Miscellaneous Petition is closed.
