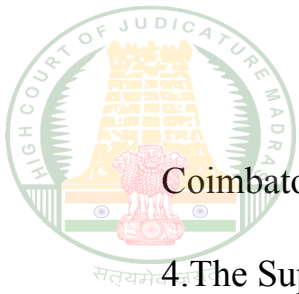

### **PRAYER**

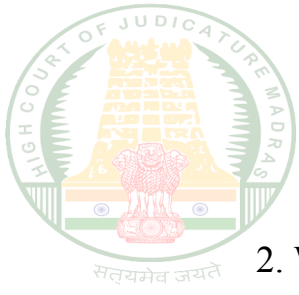

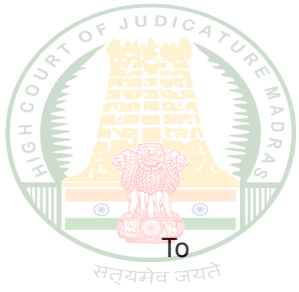
