ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the
Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2. This is an accident case, complaining of an offence under Section
279, 337 and 304(A) and 338 of Indian Penal Code, 1860. Reference can be
made to the detailed order passed by this Court dated 01.09.2025 in Sua Motu
Crl.No.618 of 2025.

3. In that view of the matter, the following was considered:

- (i) The accident was not due to any aggravated or egregious conduct.
- (ii) The victim has received compensation.
- (iii) The accused has no previous or subsequent case and a due report from the probationary officer regarding his conduct has already been received.
- (iv) The accused has also been facing the case all these years.

4. In view thereof, I find that this is a fit case where the provisions of the Probation of Offenders Act, 1958, can be invoked. Accordingly, upon the plea of the accused, the accused is found guilty of the offence under Sections 279, 337 and 304(A) and 338 of Indian Penal Code, 1860. However, without proceeding to sentence the accused, this Court releases the petitioner on probation under the Probation of Offenders Act, 1958, on the following conditions:

- (a) The accused shall execute a bond before the learned Magistrate undertaking good conduct for a

period of one year, failing which he shall appear before this Court to receive sentence.

(b) It is made clear that, as per Section 12 of the Probation of Offenders Act, 1958, the finding of guilty will not be a disqualification for any purpose.

3. Accordingly, the case in CC.No.57/2021 on the file of the Judicial Magistrate Court, Dharapuram, Dharapuram Taluk, Tiruppur shall stand disposed of and consequently, this Suo Motu Transfer Case is disposed of.
