### **ORDER**

This Contempt Petition has been filed to punish the respondents for non compliance of the order dated 01.03.2024 passed by this Court in W.P.No.3821 of 2023, thereby directed the respondents to approve the appointment of the petitioner as Secondary Grade Teacher from the date of her initial appointment, forthwith.

2. On instructions, the learned Government Advocate appearing for the respondents submitted that in the Danish Mission Elementary School, in which the petitioner is now working, there is one surplus post in the secondary teacher. In Viruthachalam district, there are nine surplus posts are available in the post of secondary teacher. Over all in Cuddalore and Viruthachalam educational district, there are 17 surplus posts in the secondary grade teacher. Therefore, the order passed by this Court could not be complied with.
