ORDER

This Criminal Original Petition has been filed to quash the FIR in

Crime No.52 of 2025 on the file of the 1st respondent-Police.

2. Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) appearing for the first respondent-Police and perused the materials available on record.

3. The case of the prosecution is that on 27.02.2025 at 2.15 a.m., some unknown persons have entered into the second respondent/*de-facto* complainant's house and stolen the ornaments, which were kept in the cupboard. Hence, a case in Crime No.52 of 2025 was registered for the offences punishable under Sections 331(4) and 305(a) of BNS, 2023.

4. The learned Government Advocate (Crl.Side) appearing for the first respondent-Police, on instructions, submitted that based on the confession statement given by the other co-accused, the petitioner has been arrested and remanded to judicial custody. He further submitted that the investigation is on and hence, the Criminal Original Petition may be dismissed.

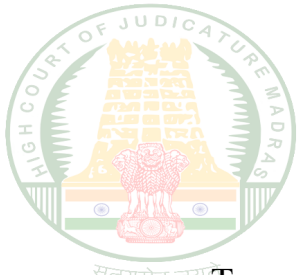

5. At this juncture, the learned counsel for the petitioner contended that the petitioner's name has not been found in the FIR and in the original complaint. Only based on the confession given by Panneer Selvam and Shanmugam, the petitioner has been falsely implicated in the alleged offences.

6. At the outset, this Court is of the view that investigation is on and part of such huge crime is unearthed and hence, this Court does not find any merit in the present petition. Accordingly, this Criminal Original Petition is dismissed. Consequently, connected miscellaneous petition is closed.
