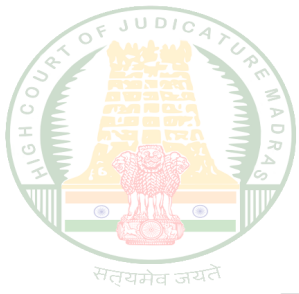

ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2. The allegations in this case is in the nature of democratic right. A case was registered in Cr. No. 119 of 2018 on 25.01.2018 for the alleged offences under Sections 143, 341 and 188 of Indian Penal Code, 1860. The final report was filed on 23.03.2017 and the accused have been facing trial since then. Thus, it can be seen that the allegations concern exercising the democratic right to protest. Given the context and nature of the allegations, continuing the trial impinges on the right to a speedy trial of the accused. No useful purpose will be served by continuing the case.

3. Accordingly, the case in C.C.No.2200245 of 2018 of Judicial Magistrate No. II, Coimbatore Taluk, Coimbatore shall stands disposed of and this Sua Motu Transfer Case stands disposed of.
