When the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the respondents submitted that the detenu, namely, Uthirakumar, had already been arrested on 19.08.2025 in connection with Crime No.216 of 2025 registered under Sections 8(c) and 20(b)(ii)(B) of Narcotic Drugs & Psychotropic Substances Act, 1985, on the file of the Inspector of Police, G2 Uthiramerur Police Station, Kanchipuram District, and remanded to judicial custody.
