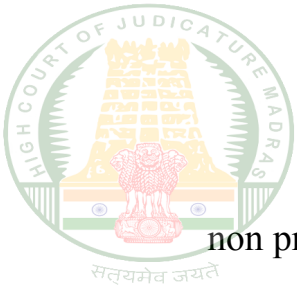
Prayer: Writ Petition filed under Article 226 of the Constitution of India
