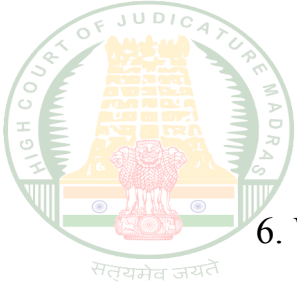

The learned Government Advocate [Criminal Side] on instructions submitted that as the accused is a lorry driver, the delay had occurred in execution of the warrant and the respondent police seeks time to execute the warrant issued as against the accused in C.C.No.847 of 2021, on the file of the learned Judicial Magistrate No.II, Namakkal.

5. In view of the submissions of the learned Government Advocate [Criminal Side] appearing for the respondent, there shall be a direction to the respondent police to execute the warrant as expeditiously as possible.
