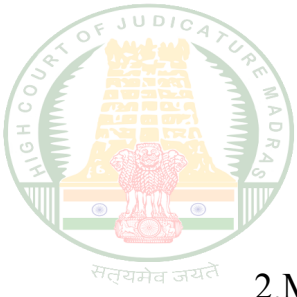

Accordingly, this writ petition is disposed of, only by directing the respondents 3 & 4 to consider the representation of the petitioner dated 04.08.2025 and pass orders on the same on



merits and in accordance with law. Such exercise shall be done by the respondents 3 & 4 within a period of four weeks from today. No costs.
