3. In view of the above, this Writ Petition is closed. No costs. Registry need not list the matter any more.

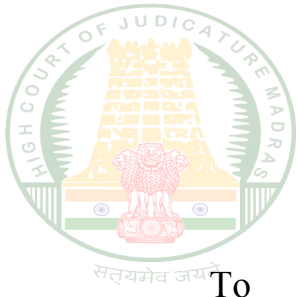
