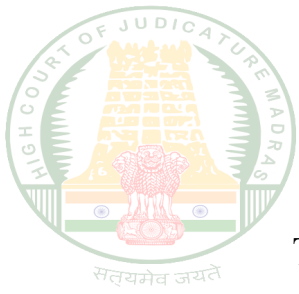

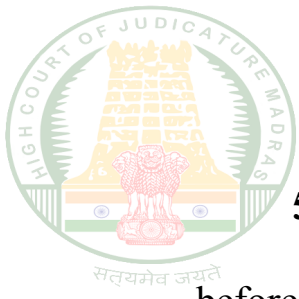
ORDER

The above Transfer Civil Miscellaneous Petition is filed seeking to withdraw IDOP.No.310/2023 pending on the file of the Principal District and Sessions Court, Thiruvallur and transfer the same to the file of the Principal District and Sessions Court, Mayiladuthurai.

2. IDOP.No.310 of 2023 has been filed by the respondent/husband seeking restoration of conjugal rights.
