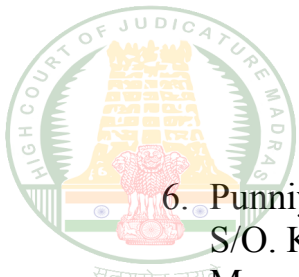

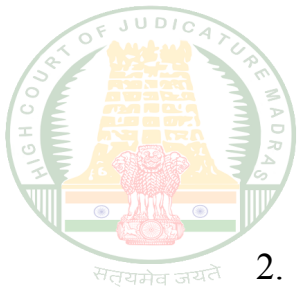

ORDER

The revision petitioner herein is the plaintiff in O.S.No.169 of 2014. The revision petitioner/plaintiff filed a petition in I.A.No.1 of 2021 under Order 1 Rule 10(2) of C.P.C. praying to implead the respondents 4 to 6 as defendants 4 to 6 in the main suit. After hearing both sides, the learned District Munsif, Gudiyattam dismissed the petition. Feeling aggrieved, the revision petitioner/plaintiff has filed the present Civil Revision Petition.



2. When the Civil Revision Petition was listed before this Court on 11.09.2025, this Court observed as follows:-

3. With a view to give one opportunity to the revision petitioner, list the matter on 19.09.2025.”

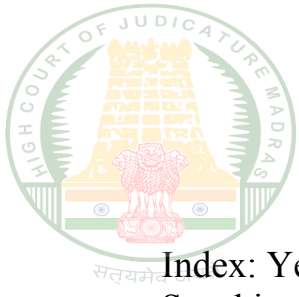
3. Again on 19.09.2025, this Court observed as follows:-
