ORDER

The Criminal Original Petition has been filed seeking to quash the First Information Report in Crime No.49 of 2025, pending investigation on the file of the first respondent Police, on the basis of the compromise arrived at between the petitioner and the de facto complainant/second respondent.

2. The crux of the allegations in the FIR is that the petitioner/accused, who got introduced to the de facto complainant through a matrimony website, developed a relationship with the de facto complainant and thereafter, on the promise of marrying her, had received several sovereigns of jewels and also had sexual intercourse with her on several occasions and thereafter has cheated her and married another woman. When the same was questioned, she was abused by using her caste name. Hence, the complaint was given and an FIR was registered in Crime

No.49 of 2025 for the offences punishable under Sections 69 of BNS and

Sections 3(1)(w)(ii), 3(1)(r) and 3(1)(s) of SC/ST (Prevention of Atrocities)

Act and now the same is sought to be quashed.

3. Heard the learned counsel appearing for both the petitioner and the de facto complainant/second respondent, the learned Government Advocate (Criminal Side) appearing for the first respondent and perused the materials available on record.

4. Now, the learned counsels appearing on either side submitted that due to intervention of well wishers, elders, relatives and after mutual discussions, both parties have realized that the matter was entirely personal in nature and continuation of criminal proceedings would only lead to unnecessary mental agony, harassment, the parties have settled the dispute between them amicably and sought to quash the proceedings in Crime No.49 of 2025 pending against the petitioner. They have also filed a Joint

Memo of Compromise executed by the petitioner and the second respondent

to that effect.

5. The petitioner and the de-facto complainant/R2 appeared before this Court and were identified by their respective counsel as well as by Ms.C.Sumathi, WSSI, AWPS, Cuddalore District.

6. On being enquired by this Court, the de facto complainant stated that she has amicably settled the dispute with the petitioner and she is not willing to pursue the criminal proceedings against the petitioner/accused.

7. Learned Government Advocate (Criminal Side) appearing on behalf of the first respondent submitted that though the parties entered into a compromise while this case is pending, this Court, taking into account the seriousness of the offence has to consider the issue as to whether an offence of this nature can be quashed on the ground of compromise between parties.

8. At the outset, this Court is of the view that the offences of serious nature, compounding is not permissible, however, taking note of the allegations pressed in the FIR, this Court is inclined to dispose of the matter on merits.

9. Section 69 of the Bharatiya Nyaya Sanhita, 2023 reads as follows :-

"Section 69 - Sexual intercourse by employing deceitful means etc. Whoever, by deceitful means or by making promise to marry a woman without any intention of fulfilling the same, and has sexual intercourse with her, such sexual intercourse not amounting to the offence of rape, shall be punished with imprisonment of either description for a term which may extend to ten years and shall also be liable to fine."

10. A perusal of the First Information Report makes it very clear that the de facto complainant is neither illiterate nor a rustic person. Though it is alleged that the accused, on the false promise of marriage, had sexual intercourse with the de facto complainant, a careful reading of the FIR

carefully indicates that the sexual intercourse took place with the consent of

the de facto complainant on multiple times. Had it been a case in which relationship developed once or twice and prosecutrix restrained the applicant for further developing physical relationship between them asking him to first fulfill the promise of marriage, then it would have been a case of false promise of marriage. Therefore, it cannot be stated that only because of deception played by the accused, she had succumbed to such a pressure.

11. To bring the case within the ambit of 'misconception of fact', there must be materials to show that bad faith or deception existed from the very inception. However, the allegations in the FIR clearly indicate that the de facto complainant and the petitioner/accused had indulged in sexual intercourse on several occasions with the consent of the de facto complainant. In such a situation, to bring the act of the accused under the ambit of misconception of facts, there must be evidence or at least some material, which is not found on perusal of the available materials.



12. The very factum that they had sexual intercourse many times indicate that the alleged deception from the very inception is absent. In such a situation, it cannot be held that such consent would fall within the ambit of misconception of fact.

13. In this regard, it is relevant to rely upon the judgment of the Hon'ble Apex Court in *Pramod Suryabhan Pawar Vs. State of Maharashtra* reported in (2019) 9 SCC 608, wherein, in paragraphs 16, 21 and 23, the Hon'ble Supreme Court has held as follows:

“16. Where the promise to marry is false and the intention of the maker at the time of making the promise itself was not to abide by it but to deceive the woman to convince her to engage in sexual relations, there is a “misconception of fact” that vitiates the woman's “consent”. On the other hand, a breach of a promise cannot be said to be a false promise. To establish a false promise, the maker of the promise should have had no intention of upholding his word at the time of giving it.

21. The allegations in the FIR do not on their face indicate that the promise by the appellant was false, or that the complainant engaged in sexual relations on the basis of this promise. There is no allegation in the FIR that when the appellant promised to marry the complainant, it was done in bad faith or with the intention to deceive her. The appellant's

failure in 2016 to fulfil his promise made in 2008 cannot be construed to mean the promise itself was false. The allegations in the FIR indicate that the complainant was aware that there existed obstacles to marrying the appellant since 2008, and that she and the appellant continued to engage in sexual relations long after their getting married had become a disputed matter. Even thereafter, the complainant travelled to visit and reside with the appellant at his postings and allowed him to spend his weekends at her residence. The allegations in the FIR belie the case that she was deceived by the appellant's promise of marriage. Therefore, even if the facts set out in the complainant's statements are accepted in totality, no offence under Section 375 of the IPC has occurred.

23. Without entering into a detailed analysis of the content of the WhatsApp messages sent by the appellant and the words alleged to have been spoken, it is apparent that none of the offences set out above are made out. The messages were not in public view, no assault occurred, nor was the appellant in such a position so as to dominate the will of the complainant. Therefore, even if the allegations set out by the complainant with respect to the WhatsApp messages and words uttered are accepted on their face, no offence is made out under SC/ST Act (as it then stood). The allegations on the face of the FIR do not hence establish the commission of the offences alleged.“

14. The Hon'ble Supreme Court in *Sonu Vs. State of Uttar Pradesh*

reported in *AIR 2021 SC 1405* has held in paragraphs 9 and 11 as follows:

“9. In Pramod Suryabhan Pawar (supra), while dealing

with a similar situation, the principles of law which must govern a situation like the present were enunciated in the following observations:

“Where the promise to marry is false and the intention of the maker at the time of making the promise itself was not to abide by it but to deceive the woman to convince her to engage in sexual relations, there is a “misconception of fact” that vitiates the woman's “consent”. On the other hand, a breach of a promise cannot be said to be a false promise. To establish a false promise, the maker of the promise should have had no intention of upholding his word at the time of giving it...?”

11. Bearing in mind the tests which have been enunciated in the above decision, we are of the view that even assuming that all the allegations in the FIR are correct for the purposes of considering the application for quashing under Section 482 of CrPC, no offence has been established. There is no allegation to the effect that the promise to marry given to the second respondent was false at the inception. On the contrary, it would appear from the contents of the FIR that there was a subsequent refusal on the part of the appellant to marry the second respondent which gave rise to the registration of the FIR. On these facts, we are of the view that the High Court was in error in declining to entertain the petition under Section 482 of CrPC on the basis that it was only the evidence at trial which would lead to a determination as to whether an offence was established.”

15. The Hon'ble Supreme Court in the case of *Mahesh Damu Khamre*

vs. State of Maharashtra and others reported in reported in 2024 SCC 10/16



Online 3471 although considered the case of 376 IPC on a false promise of

marriage but taking note of the fact and observation made by the Supreme

Court it is clear that if relationship is continued for long then it cannot be

presumed that the said relationship is developed due to false promise of

marriage. The observation made by the Supreme Court is as under :-

"22. In our view, if a man is accused of having sexual relationship by making a false promise of marriage and if he is to be held criminally liable, any such physical relationship must be traceable directly to the false promise made and not qualified by other circumstances or consideration. A woman may have reasons to have physical relationship other than the promise of marriage made by the man, such as personal liking for the male partner without insisting upon formal marital ties. Thus, in a situation where physical relationship is maintained for a prolonged period knowingly by the woman, it cannot be said with certainty that the said physical relationship was purely because of the alleged promise made by the appellant to marry her. Thus, unless it can be shown that the physical relationship was purely because of the promise of marriage, thereby having a direct nexus with the physical relationship without being influenced by any other consideration, it cannot be said that there was vitiation of consent under misconception of fact.

...

27. Thus, from the above it appears that it is more of an extra-marital affair during the aforesaid period without any insistence by the complainant for getting married to the appellant. The fact that the complainant continued to have a

physical relationship for a long time without any insistence on marriage would indicate the unlikelihood of any such promise made by the appellant for marrying her and it rather indicates that the relationship was a consensual one. In our opinion, the longer the duration of the physical relationship between the partners without protest and insistence by the female partner for marriage would be indicative of a consensual relationship rather than a relationship based on false promise of marriage by the male partner and thus, based on misconception of fact".

16. Further, the Hon'ble Supreme Court in the case of *Bishwajyothi Chatterjee vs. State of West Bengal and another* reported in 2025 Live Law (SC) 404 has observed as to when relationship cannot be considered to be of a false promise of marriage.

"20. We find that there is a growing tendency of resorting to initiation of criminal proceedings when relationships turn sour. Every consensual relationship, where a possibility of marriage may exist, cannot be given a colour of a false pretext to marry, in the event of a fall out. It is such lis that amounts to an abuse of process of law, and it is under such circumstances, that we deem fit to terminate the proceedings at the stage of charge itself".

17. Thus it is clear from the aforesaid enunciation of law and observations made by the Hon'ble Supreme Court so as to substantiate the

relationship between the parties cannot be considered to be developed on a false pretext of marriage.

18. In the present case also, considering the existing factual circumstances as has been narrated by the prosecutrix in the FIR and if the same is considered to be true at its face value, it is clear that the said relationship is not on a false promise of marriage and as such material ingredients of Section 69 of BNS are completely missing and this relationship cannot be considered to be a relationship developed on a false promise of marriage.

19. That apart, now, the de facto complainant and the petitioner settled the matter between themselves and has also filed a Joint Memo of Compromise dated 14.07.2025 seeking to quash the proceedings against the petitioner/accused.

20. Accordingly, this Criminal Original Petition is allowed. The

proceedings in Crime No.49 of 2025 pending investigation on the file of the first respondent Police, is quashed as against the petitioner. The Joint Memo of Compromise filed by the petitioner and the second respondent for compromising the offences shall form part of the record.
