ORDER

Mr.Edwin Prabhakar states, after the last hearing, survey has been conducted and a report dated 28.01.2025 has been prepared. Copy of the report is at Serial No.5 of a typed set being filed by the first respondent.

2. Mr.Prabhakar states that the survey was conducted in the presence of the petitioner and even the petitioner is supposed to have encroached. He states that notice under Section 7 of the Tamil Nadu Land Encroachment Act, 1905 has been issued to all encroachers including the petitioner and
