The instant writ petition has been filed to call for the records of the 3rd respondent, the District Manager (TASMAC) Coimbatore (South) District culminating in Na.Ka.No.257/2025/RVI dated 02.04.2025 and quash the same and pass further direction to the 3rd respondent to reinstate the petitioner into service as salesman in the Tasmac Shop No.1656, Coimbatore (South) District.

2. Learned counsel appearing for the petitioner would submit that for no fault on the part of the petitioner, he was suspended from service on the ground that there is a MRP violation. It is the contention of the petitioner that on a particular day, the petitioner was not sold any Beer Bottles more than MRP as alleged in the Memorandum. Therefore, the suspension is *ipso facto* void. Though, the learned counsel raised such an objection, he restrict his prayer that if the respondents dispose of the proceedings pending against the petitioner within a reasonable time, the same would satisfy the petitioner.

3. In view of the aforesaid submission made by the learned counsel for the petitioner, without going to the merits of this Writ Petition, the

3rd respondent is directed to complete the enquiry in respect of the petitioner's suspension order dated 02.04.2025 and pass final orders on its own merits and in accordance with law, within a period of four(4) weeks from the date of receipt of a copy of this order.

4. In the result, this Writ Petition is disposed of with the above directions. Consequently connected miscellaneous petition is closed. No costs.

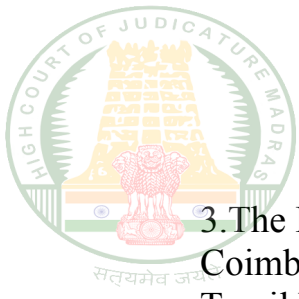
