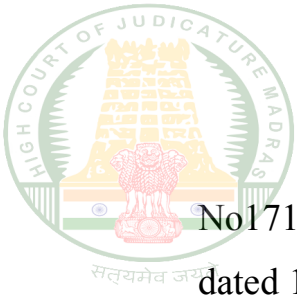

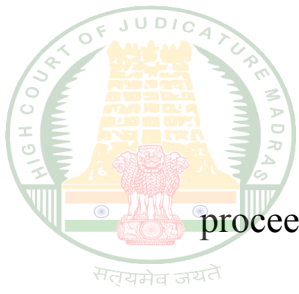

ORDER

The instant writ petition has been filed to call for the records of the 3rd respondent, the District Manager / deputy Collector (TASMAC) Coimbatore (North) District to revoke the order of suspension in Na.Ka.No.165/2022/A1 dated 03.04.2025 and pass appropriate orders reinstating the petitioner into service as salesman in the Tasmac Shop No1711 Coimbatore (North) District by considering his representation, dated 15.08.2025.

2. Learned counsel appearing for the petitioner would submit that for no fault on the part of the petitioner, he was suspended from service on the ground that there is a MRP violation. It is the contention of the petitioner that on a particular day, the petitioner has not sold any Beer Bottles more than MRP as alleged in the Memorandum. Therefore, the suspension is *ipso facto* void. Though, the learned counsel raised such an objection, he restrict his prayer that if the respondents dispose of the

proceedings pending against the petitioner within a reasonable time, the same would satisfy the petitioner.

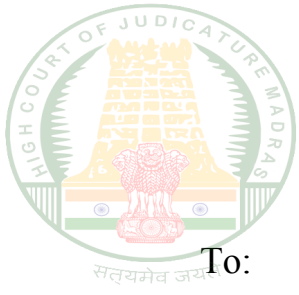
