2. Recording the submission of the learned counsel for the petitioner and the endorsement made, this Writ Petition is dismissed as withdrawn. No costs.

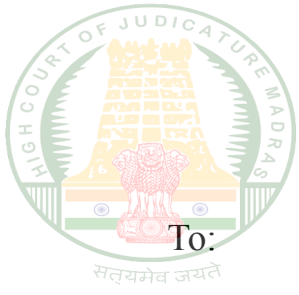
