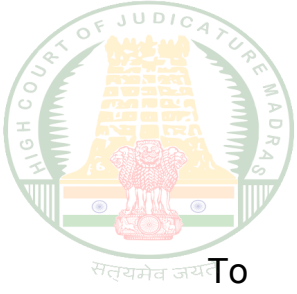
2. Heard the learned counsel on either side and perused the documents placed on record.
