ORDER

This Sua Motu Case is dealt with in an extraordinary manner by the Dedicated Bench, pursuant to Sua Motu.W.P.(Crl.) No.618 of 2025.

2. This is an accident case, complaining of an offence under Section 304(A) of Indian Penal Code, 1860. Reference can be made to the detailed order passed by this Court dated 01.09.2025 in Sua Motu W.P.(Crl.) No.618 of 2025.

3. In that view of the matter, the following was considered:

- (i) The accident was not due to any aggravated or egregious conduct.
- (ii) The victim has received compensation.
- (iii) The accused 1& 2 has no previous or subsequent case and a due report from the probationary officer regarding their conduct has already been received.

(iv) The accused has also been facing the case all these years.

4. In view thereof, I find that this is a fit case where the provisions of the Probation of Offenders Act, 1958, can be invoked. Accordingly, upon the plea of the accused, the A1 is found guilty of the offence under Sections 279, 338 and 304(A) of Indian Penal Code, 1860 and A2 is found guilty of the offence under Sections 279 and 304(A) of Indian Penal Code, 1860. However, without proceeding to sentence the accused 1 & 2, this Court releases the accused 1 & 2 on probation under the Probation of Offenders Act, 1958, on the following conditions:

(a) The accused 1 & 2 shall execute a bond before the learned Magistrate undertaking good conduct for a period of one year, failing which they shall appear before this Court to receive sentence.

(b) It is made clear that, as per Section 12 of the Probation of Offenders Act, 1958, the finding of guilty will not be a disqualification for any purpose.

5. Accordingly, the case in C.C.No.2800050 of 2016 on the file of Judicial Magistrate No. VIII, Coimbatore Taluk, Coimbatore shall stands disposed of and this Suo Motu Transfer Case stands disposed of.
