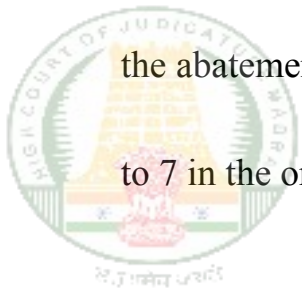

**COMMON ORDER**

The second respondent in O.P.No.826 of 2019 by name A.Dilli Babu died on 01.06.2023, leaving behind his wife and sons, as his legal heirs.

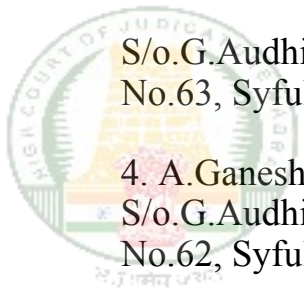
