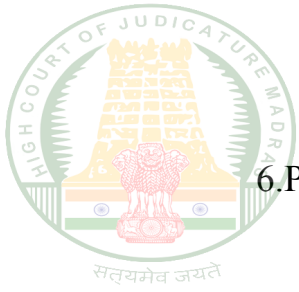

Such exercise shall be done by the 3rd respondent within a period of four weeks from today. No costs.
