ORDER

This *Suo Motu* Case is dealt with in an extraordinary manner by the
Dedicated Bench, pursuant to *Suo Motu W.P.(Crl.) No.618 of 2025*.

2.The case was registered in Cr.No.79 of 2017 for the alleged offence
under Section 160 of the I.P.C. The occurrence is said to have taken place on
27.02.2017. The allegation in this case is that as two groups scrambling
position over property were trying to create law and order situation. It is stated
that the civil dispute is pending between the parties. Therefore, the parties

have to take care of their dispute in the concerned civil matter. The First Information Report was registered only under Section 160 I.P.C. and the matter has been pending since 2017.

3.Considering the factual matrix, context of the case, the antecedents of the accused, the reason for absence from his usual place, and the submission that, despite best efforts, the warrant could not be executed, it is evident that even if the accused is brought to face trial, it would impinge upon his right to a speedy trial. Due to the passage of time, a meaningful trial is unlikely, and no useful purpose would be served.

4.Accordingly, the case in S.T.C.No.68 of 2020 of District Munsif Cum Judicial Magistrate, Cheyyur Taluk, Chengalpattu, stands quashed. This *Suo Motu* Transfer Case is disposed of.
