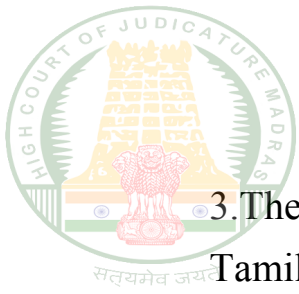

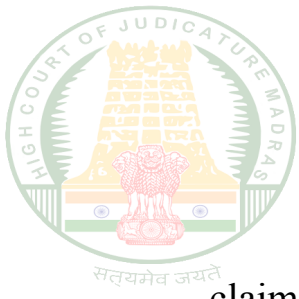

5. In view of the aforesaid directions, the Writ Petition is disposed. No costs.

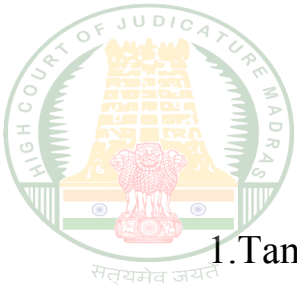

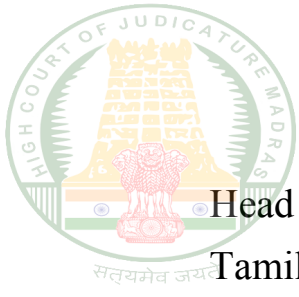
